Item 2. Acquisition or Disposition of Assets

Aboitiz Power Corporation (AP) has entered into an agreement today to buy the 20% equity of Team Philippines Industrial Power II Corporation (formerly: Mirant (Phils.) Industrial Power II Corp.) in Subic Enerzone Corporation (SEZ) for P92 million. Together with the 35% equity in SEZ of its subsidiary Davao Light and Power Company, Inc., the present acquisition brings AP's total equity in SEZ to 100%.

AP previously acquired a total of 25% equity in SEZ from San Fernando Electric Light and Power Co., Inc., Okeelanta Corporation,

Pampanga Sugar Development Corporation and Aboitiz Equity Ventures, Inc. through a shares-for-shares swap. The swap is still pending before the Securities and Exchange Commission for approval.

SEZ operates the power distribution system of the Subic Bay Freeport Zone under a 25-year distribution management services agreement with the Subic Bay Metropolitan Authority, which SEZ won through competitive bidding in 2003.
