Item 9. Other Events

The Power Sector Assets and Liabilities Management Corporation (PSALM) today issued the Notice of Award to SN Aboitiz Power Hydro, Inc. (SNAP Hydro), a consortium between Aboitiz Power Corporation and SN Power AS of Norway, officially declaring SNAP Hydro as the winning bidder for the Ambuklao-Binga Hydroelectric Power Plant Complex consisting of the 75MW Ambuklao Hydroelectric Power Plant located at Bokod, Benguet and the 100 MW Binga Hydroelectric Power Plant located at Itogon, Benguet. The price offered for the hydroelectric complex amounted to US\$325 million.

The Asset Purchase Agreement for the hydroelectric complex requires SNAP Hydro to deliver at least 40% of the purchase price of US\$325 million as upfront payment payable on or before the closing date. The balance of 60% may be paid in 14 equal semi-annual payments with an interest of 12% per annum compounded semi-annually.

Soon after making the downpayment, PSALM will turn over to SNAP Hydro the hydroelectric complex.
