Aboitiz Power Corporation (AP) was informed by Redondo Peninsula Energy, Inc. (RP Energy) that, after revisiting the power demand and supply situation in the Luzon Grid, RP Energy has decided to pursue the 300–MW coal-fired power plant project in the Subic Bay Freeport Zone (the "Subic Coal Project"). The RP Energy management now believes that the economic environment makes the Subic coal project more feasible. RP Energy is in talks with prospective turnkey contractors for the EPC contract for the Subic Coal Project.

The Board of Directors of AP had previously approved its investment in RP Energy and the Subic Coal Project but deferred its project timetable.

RP Energy is the joint venture company between AP and Taiwan Cogeneration International Corporation for the Subic Coal Project.
