Item 9: Other Events

Aboitiz Renewables, Inc. (ARI), a wholly owned holding company of Aboitiz Power Corporation (AboitizPower) for its renewable energy assets, entered into a compromise agreement with Pacific Hydro Bakun, Inc. (PHBI) for the settlement of the shareholders' dispute arising out of the public bidding for the IPP Administrator contract of the 70MW Bakun run-of-river hydropower plant (Bakun Hydro Plant). Prior to the date ARI assumed full control of LHC, PHBI was the joint venture partner of ARI in Luzon Hydro Corporation (LHC), the IPP operator of the Bakun Hydro Plant in Ilocos Sur.

As previously disclosed, the shareholders' dispute resulted in the filing by ARI of a complaint for tortious interference in contractual relations and exercise of property

rights against PHBI. On the other hand, PHBI filed a derivative suit against ARI on behalf of LHC to compel ARI to bid together with PHBI for the IPP Administrator contract of the Bakun Plant.

On May 10, 2011, ARI assumed full control and ownership of LHC upon completion of the conditions under its Memorandum of Agreement with PHBI.
