Item 9: Other Events

Aboitiz Power Corporation (AboitizPower) was informed by its affiliate, SN Aboitiz Power-Benguet, Inc. (SNAP-Benguet), that Unit 3 of the 75-MW Ambuklao Hydroelectric Power Plant (Ambuklao Plant) located in Bokod, Benguet commenced commercial operations.

Unit 3, which has a rated capacity of 35 MW, is one of the three generating units of the Ambuklao Plant that was rehabilitated in 2008 following its turn over by Power Sector Assets and Liabilities Management Corporation (PSALM). The rehabilitation works will restore and increase Ambuklao Plant's generating capacity from 75 MW to 105 MW. The rehabilitation project involving the remaining units is scheduled to be completed by the 3rd quarter of 2011.

SNAP-Benguet, a consortium between Aboitiz Renewables, Inc. and SN Power AS, took over the Ambuklao Plant after a successful public bidding conducted by PSALM for the acquisition of the Ambuklao-Binga Hydroelectric Power Complex, consisting of the Ambuklao Plant and the 100-MW Binga Hydroelectric Power Plant located in Itogon, Benguet.
