Item 9: Other Matters

Aboitiz Power Corporation (AboitizPower) was informed today by its wholly owned subsidiary Therma Power, Inc (TPI), that it has signed a Shareholders' Agreement with Meralco PowerGen Corporation (MPGC) and Taiwan Cogeneration International Corporation – Philippine Branch (TCIC) to formalize MPGC's participation in the construction and operation of a 600 MW independent coal-fired power plant in the Subic Bay Freeport Zone.

Redondo Peninsula Energy, Inc. (RP Energy) will serve as the joint venture company of AboitizPower, MPGC and TCIC, and the vehicle for the implementation of the proposed Subic Bay coal-fired power plant.


As previously disclosed, MGPC will take the controlling interest in RP Energy, with TPI and TCIC owning the remaining stake equally.
