Item 9: Other Matters

Aboitiz Power Corporation (AboitizPower) was advised by its affiliate, SN Aboitiz Power-Benguet, Inc. (SNAP-Benguet), that it has received today the Certificate of Compliance from the Energy Regulatory Commission, valid for five years, for its Binga Hydroelectric Power Plant (HEPP) Unit 4 Turbine located in Brgy. Tinongdan, Itogon, Benguet.

Unit 4, which was upgraded from 25 megawatts (MW) to 31.45 MW, began its refurbishment and upgrading in April 2011 and was completed in December of the same year.

As previously disclosed, SNAP-Benguet, a consortium between Aboitiz Renewables, Inc. and SN Power, is the owner and operator of the Ambuklao-Binga Hydroelectric Power Complex, consisting of the 75-MW Ambuklao Plant located in Bokod,


Benguet and the 100-MW Binga Hydroelectric Power Plant located in Itogon, Benguet.
