In compliance with the requirements of Securities and Exchange Commission Memo Circular No. 4 (Series of 2012) (the "SEC Memo"), Aboitiz Power Corporation ("AboitizPower") hereby certifies that:

- 1. It has a Board Audit Committee (the "Committee") governed by a formal written charter that includes provisions regarding the Committee's purpose, duties, responsibilities and membership requirements. The Committee's charter was revised to align with the provisions of the SEC Memo (the "Revised Charter") and was approved by the Board of Directors in its meeting last September 27, 2012.
- 2. The Revised Charter contains a provision on performance assessment which states that "The Committee shall assess its performance through an annual self-assessment. Prior year performance assessment shall be done during the first Committee meeting the following year." Thus, its first Committee self-assessment shall be conducted within the first quarter of 2013.
- 3. In lieu of the self-assessment for 2011, the Committee participated in the External Quality Assurance Review of the Internal Audit function conducted by the Institute of Internal Auditors-Philippine Chapter (IIA-P) where it was given a rating of "Generally Compliant". This supports and further strengthens AboitizPower's commitment to ensure quality, professional standards and adherence to good corporate governance practices.
